She is a Product Manager and Content Developer at Convergence Training in Camas, and has lived in Washougal for 20 years. She and her family can often be found hanging out at the Washougal River, which they live next to.

We will present an update to the Chamber, illustrating the needs in our community and the significant impact your donations have made. The Camas-Washougal Community Chest kicked off its annual fundraising campaign in October. The Community Chest has an all-volunteer board, zero paid employees, and we keep our expenses low (under 3%) to maximize the impact of your donations in our community. Last year, your donations helped the Community Chest make \$128k in grants to 28 local agencies, providing over 19,500 individual services. Here are a couple highlights:

- 25,175 meals were prepared and delivered to 201 local seniors by Meals On Wheels People. That's more than double the meals they served in 2019
- 3,744 food bags were distributed to 178 families by the Inter-Faith Treasure House and, 2,000 people collected free bread, dairy, produce and meat from their porch monthly.
- The General Federation of Women's Clubs-Camas Washougal continued their support of early childhood education by distributing 944 books via school bus to local preschoolers.
